

# BAYTOWN NEIGHBORHOOD TRAFFIC MANAGEMENT

Baytown's Neighborhood Traffic Management Process can be applied to neighborhood streets that are within the City Limits of Baytown. If a resident notices high speeds and/or high traffic on a neighborhood street, the resident can submit an application for the City of Baytown (COB) to study potential traffic calming methods, like installing speed cushions. Neighborhood streets must meet several requirements to implement a traffic calming plan. ## Frequently Asked Questions:

**My street is a cut-through street, can I apply for speed cushions?** Any resident with concerns about speeding or high traffic volumes can submit an application.

**What if I want the COB to put in a stop sign?** You can fill out this application to have the COB Traffic Engineer evaluate if a stop sign is needed at the particular intersection.

**What happens after I submit an application?** On the back of this card there is a chart that outlines the process.

**How long does the process take from application to implementation?** An estimated 8 - 12 months. To learn more about the time for each step visit [www.baytownengage.com](http://www.baytownengage.com).

# BAYTOWN NEIGHBORHOOD TRAFFIC MANAGEMENT PROCESS

## 7: IMPLEMENTATION

As funding allows, the City will install the traffic calming devices in the impact area.

### 1: SUBMIT APPLICATION

Neighborhoods can submit an application to initiate the traffic management process through [www.baytownengage.com](http://www.baytownengage.com).

### 3: CITY SHARES RESULTS

After the Study is complete, the City will share the results with the individuals who submitted the application.

### 5: ANALYZE ENGAGEMENT DATA

The City will collect and analyze the engagement data from the neighborhood impact area.

### 6: PLANNING & ZONING REVIEW

If the neighborhood is in favor of the traffic calming plan, the plan will go to the Planning and Zoning Commission for approval.

### 4: ENGAGEMENT PERIOD BEGINS

If the impact area meets the requirements for a traffic calming plan, the City will begin an engagement process to receive neighborhood feedback on the proposed plan.

### 2: CITY TRAFFIC STUDY

If the street qualifies, the City will conduct a traffic study in the neighborhood impact area.
